

Fees Schedule 2020

Effective from 1 January 2020

Enrolment Application Fee

The Enrolment Application fee of **\$110.00** (GST included) per child is paid once the application is lodged and is non-refundable. This fee covers the administrative cost of enrolment and the **initial** interview. The enrolment process will not commence prior to the application fee being paid.

Enrolment Confirmation Fee

The Enrolment Confirmation Fee of **\$500.00** per child is non-refundable and holds a position for the child in the class. Enrolment confirmation is subject to payment of the confirmation fee. Your enrolment is not completed until the enrolment confirmation fee has been received.

The Enrolment Confirmation Fee covers the administration costs associated with processing your child's application. This involves registering and reviewing your child's documents, organising and holding interviews with the Class Teachers and School Principal, evaluation of your child's needs and the suitability of the school to your child. This also covers the preparation and submission of student data to the government so that we can receive funding and keep the tuition fees at a reasonable level to be able to provide your child with a quality education and resources.

Building Levy

The Building Levy is not subject to discount or refund. ***The full levy will be charged to families that enrol at any time throughout the year.*** This levy will not be refunded if you withdraw your enrolment from the school at any time during the year. The Building Levy assists in the construction, renovation, extension and maintenance of buildings and other educational facilities and equipment (e.g. desks, library, technology), which are essential to enable the provision of quality education. These funds form an integral component of the School's Budget and Financial operations. The levy is charged once per family each year regardless of when the families enrol throughout the year.

Steiner Education Australia Levy

Steiner Education Australia is the peak body for Australian Steiner schools and advocate, promote, support and represent member schools Australia-wide. The SEA Levy is not subject to discount or refund and is charged to families that enrol at any time during the year.

Tuition Fees

Tuition fees include tuition for the compulsory instrumental music program from Class 3 to Class 7, most camps, learn to swim, and an allowance for general classroom materials.

The tuition fee does not cover items such as musical instruments, pencil boxes, clothes, hats, lunches, or instrument hire.

In exceptional circumstances, the costs of excursions, camps and transport are charged out at cost on a user pays basis.

Payment

Tuition fees will be charged quarterly at the beginning of each term. The Building Levy and SEA Levy School fees are charged annually at the beginning of the school year.

Methods of Payment

The schools preferred methods of payment are via the Parent Lounge, Direct Debit, B-Pay, Mastercard or VISA.

Please do not send cash to school with your child.

Option 1: Annual Payment

The annual payment of full fees by 31 January 2020 will be eligible for a 5% discount on tuition fees.

Option 2: Per Term Payment

School fees are invoiced four times per year, approximately two weeks prior the start of each term. Fees invoiced will be due and payable by end of the second week of each term on the following dates.

Term 1: 7th February 2020

Term 2: 30th April 2020

Term 3: 24th July 2020

Term 4: 16th October 2020

Option 3: Direct Debit Payments

The school offers weekly, fortnightly or monthly payment plans via Direct Debit (set up by the school to your nominated bank account or credit card). Forms are available via the Parent Lounge, school website or at the school office.

Monthly payments will be spread over 11 monthly payments and will be due by the last day of each month, starting by 31 January 2020 and ending 27 November 2020.

Fortnightly payments will be spread over 22 fortnightly payments and will be due by the last day of each fortnight, starting by the 31 January 2020 and ending 27 November 2020.

Weekly payments will be spread over 44 weekly payments and will be due by the last day of each week, starting by the 31 January 2020 and ending 27 November 2020.

New enrolments during 2020 will be required to set up this option via Direct Debit Forms that are available at the school office or on the School website: <https://www.noosasteiner.qld.edu.au/enrolment/fees>

It is important to contact the School if you are unable to pay your fees by the due date. In the event of a default on a monthly payment the school reserves the right to rescind the payment plan offer.

Please note: It is the parent's responsibility to set-up regular payment plans via direct debit with the school.

Late Payment

Unless prior arrangements are made with the school, fees that are overdue for longer than 1 month without any arrangements in place will incur late payment charges of \$50.00 (plus GST) per month from the date payment is due until fees are paid. The School may terminate the enrolment of a student if School fees remain unpaid at the end of a term for which the fees are due. Fees outstanding after a student's enrolment ends for any reason will be referred to a collection agency.

Communication with the office is vital.

Sibling Discounts

While the costs of educating students remains the same, the school recognises that school fees can be more difficult for larger families. Fee concessions are offered to families with more than one child. The eldest child in the family who is enrolled at the school is considered the first child in every case and discounts apply in order of the first to the last child.

- 2nd child 10%
- 3rd child 20%
- 4th and subsequent children 30%

Financial Assistance

A limited amount of concessional financial assistance may be available for families in short-term financial difficulty. Please contact the Principal to find out more.

Early Withdrawal from School

Ten (10) school-term weeks' notice, in writing, from the person responsible for the payment of school fees and addressed to the Principal is required for the intended withdrawal of a student from school. **Full fees are payable in lieu** if this notice is not provided.

Community Participation

Families who enrol at the Noosa Pengari Steiner School are asked to make a commitment to the school community by attending working bees and assisting at the annual Pengari Children's Festival. Your involvement is truly invaluable to the School and the students (as well as fun).

Fees Variation

It is the intention of the School Board that the fee levels set prior to the start of each school year will remain in force for the whole of the year. However, the right is reserved to change the level of fees during the year, if factors outside the control of the School Board impact significantly upon the cost of operating the school.
